#### PART- I

### INTER-PARLIAMENTARY UNION RELATED ACTIVITIES

(A) REPRESENTATION OF INDIAN PARLIAMENTARY GROUP IN THE STATUTORY ASSEMBLIES OF THE INTER-PARLIAMENTARY UNION AND OTHER SPECIALIZED MEETINGS

# 1. <u>140<sup>TH</sup> ASSEMBLY OF THE INTER-PARLIAMENTARY UNION (IPU) HELD IN DOHA, QATAR FROM 6 TO 10 APRIL, 2019</u>

The 140th Assembly of the Inter-Parliamentary Union was held in Doha (Qatar) from 6 to 10 April, 2019. A two member Indian Parliamentary Delegation led by Shri Harivansh, Deputy Chairman, Rajya Sabha attended the Assembly. Dr. (Smt.) Sonal Mansingh, MP, Rajya Sabha was the other member on the delegation. Smt. Snehlata Shrivastava, Secretary General, Lok Sabha and Dr. P.P.K. Ramacharyulu, Secretary, Rajya Sabha Secretariat also attended the Assembly. Shri P.C. Koul, Joint Secretary, Lok Sabha Secretariat was Secretary to Delegation.

Deputy Chairman, Rajya Sabha participated in the General Debate on 'Parliaments as platforms to enhance education for peace, security and the rule of law'. The Assembly adopted a declaration on the same. The Assembly chose the item "Call for urgent international action to support Mozambique, Malawi and Zimbabwe hit by Cyclone Idai" as an Emergency item and adopted a resolution on the said theme also.

The Assembly held deliberations and adopted resolutions on the following subject items under the purview of the Standing Committees of IPU:-

- (i) First Standing Committee of IPU on Peace and International Security

  'Non admissibility of using mercenaries as means of undermining peace and violating human rights'.
- (ii) Second Standing Committee of IPU on Sustainable Development, Finance and Trade

'The role of fair and free trade and investment in achieving the SDGs, especially regarding economic equality, sustainable infrastructure, industrialization and innovation'. Besides, Panel discussions/expert hearings were also held under the purview of following Standing Committees of IPU:-

- 'Achieving Universal Health Coverage by 2030: The role of Parliaments in ensuring the right to health'
- (iv) Fourth Standing Committee of IPU on United Nations Affairs.
- 'Parliamentary follow-up on the Sustainable Development Goals (SDGs) in preparation for the 2019 session of the United Nations High-level Political Forum (HLPF) on Sustainable Development'
- 'Main theme of the 2019 HLPF: Empowering people and ensuring inclusiveness and equality'

During the Assembly, the Indian Parliamentary Delegation also participated in the Meetings of Forum of Women Parliamentarians; Governing Council; Regional Geo-political Group (Asia-Pacific Group) and other IPU Bodies.

Smt. Snehlata Srivastava, Secretary General, Lok Sabha and Dr. P.P.K. Ramacharyulu, Secretary, Rajya Sabha Secretariat attended the meetings of the Association of Secretaries- General of Parliaments (ASGP). The Secretary General, Lok Sabha presented a communication on "The use of ICT in the Indian Parliament: Promoting Transparency and Efficiency" during the ASGP meeting.

On the sidelines of the above Assembly, bilateral meetings were held between the Indian Parliamentary Delegation and the Parliamentary delegations from Nepal, Bhutan, Cambodia, Serbia and Vietnam.

# 2. <u>FOURTH SOUTH ASIAN SPEAKERS' SUMMIT ON ACHIEVING SUSTAINABLE DEVELOPMENT GOALS (SDGS) HELD IN MALE, MALDIVES ON 1 AND 2 SEPTEMBER, 2019</u>

The Fourth South Asian Speakers' Summit on Achieving Sustainable Development Goals was held in Male, Maldives on 1 and 2 September, 2019. The above event was organized by Inter-Parliamentary Union in partnership with the People's Majlis of Maldives.

Shri Om Birla, Speaker Lok Sabha led the Indian Parliamentary Delegation to the Summit. He was accompanied by Shri Harivansh, Deputy Chairman, Rajya Sabha attended the Summit. Smt. Snehlata Shrivastava, Secretary General, Lok Sabha and Shri Desh Deepak Verma, Secretary General, Rajya Sabha were also part of the delegation. Shri P.C.Koul, Joint Secretary, Lok Sabha Secretariat was the Secretary to the Delegation.

Following sessions were held during the Summit.

(i) Plenary Session: Follow up to Colombo Declaration (2018)

- (ii) Session II: Achieving SDGs 2 and 3- Nutrition and food security as drivers of maternal, child and adolescent health in the Asia Pacific Region.
- (iii) Session III: Catalyzing the global agenda on ultimate change overcoming challenges and utilizing opportunities to strengthen the regional agenda for delivering on the Paris Agreement.

A roundtable session for the Speakers of participating Parliaments was also organized during the Summit to further exchange view on issues discussed during the Summit.

The Summit adopted 'Male Declaration' an outcome document containing summary of conclusions and recommendations of the meeting.

# 3. <u>MEETING OF STANDING COMMITTEE ON BUDGET AND PLANNING OF ASIAN PARLIAMENTARY ASSEMBLY (APA) HELD IN BAGHDAD (IRAQ) FROM 3 TO 5 SEPTEMBER, 2019</u>

The Meeting of Standing Committee on Budget and Planning of Asian Parliamentary Assembly (APA) was held in Baghdad (Iraq) from 3 to 5 September, 2019. Shri Bhartruhari Mahtab, MP Lok Sabha participated in the event. During the meeting Draft Resolution on APA Budget and Planning was considered and adopted.

# 4. IPU-UN REGIONAL CONFERENCE ON COUNTERING TERRORISM AND EXTREMISM HELD IN KUALA LUMPUR, MALAYSIA FROM 30 SEPTEMBER TO 3 OCTOBER, 2019

IPU-UN Regional Conference on Countering Terrorism and Extremism was held in Kuala Lumpur, Malaysia from 30 September to 3 October, 2019. An Indian Parliamentary Delegation consisting of Shri Vishnu Dayal Ram, MP, Lok Sabha – Leader of the Delegation and Smt. Sampatiya Uikey, MP, Rajya Sabha attended the above Conference. Ms. Rimjhim Prasad, Joint Secretary, Lok Sabha Secretariat was the Secretary to the Delegation. The main theme of the Conference was "The role of Parliamentarians in preventing and countering terrorism and addressing conditions conducive to terrorism in Asia Pacific region".

An Outcome Document was adopted at the end of the Conference.

# SESSION WITHIN THE FRAMEWORK OF WTO PUBLIC FORUM 2019; AND (iii) WTO PUBLIC FORUM 2019 HELD IN GENEVA, SWITZERLAND FROM 7 TO 11 OCTOBER, 2019

Shri Rajeev Pratap Rudy, MP, Lok Sabha and the member of the IPU Steering Committee of Parliamentary Conference on WTO participated in the above meetings. During the above meetings, discussions were held on the following themes:-

- (i) Update on recent developments at the WTO including preliminary discussion on the arrangements for the Parliamentary Conference on the WTO on the occasion of the 12<sup>th</sup> Ministerial Conference in Nur-Sultan (Kazakhstan)
- (ii) Trade Forward: Adapting to a Changing World.
- (iii) What role for Parliamentarians in digital trade?

# 6. <u>141<sup>ST</sup> ASSEMBLY OF THE INTER-PARLIAMENTARY UNION (IPU) HELD IN BELGRADE (SERBIA) FROM 13 TO 17 OCTOBER, 2019</u>

The 141<sup>st</sup> Assembly of the IPU was held in Belgrade, Serbia from 13 to 17 October, 2019. An Indian Parliamentary Delegation led by Shri Om Birla, Speaker, Lok Sabha and consisting of Dr. Shashi Tharoor, MP Lok Sabha, Ms. Kanimozhi Karunanidhi, MP Lok Sabha, Smt. Wansuk Syiem, MP Rajya Sabha, Dr. Bharatiben Dhirubhai Shyal, MP Lok Sabha, Ms. Shobha Karandlaje, MP Lok Sabha, Shri Ram Kumar Verma, MP Rajya Sabha and Shri Sasmit Patra, MP Rajya Sabha attended the Assembly. Smt. Snehlata Shrivastava, Secretary General, Lok Sabha and Shri Desh Deepak Verma, Secretary General, Rajya Sabha and members of Association of Secretaries General of Parliaments (ASGP) also attended the Assembly. Shri P. C. Koul, Joint Secretary, Lok Sabha Secretariat was the Secretary to the Delegation.

Speaker, Lok Sabha participated in the General Debate in Assembly on the overall theme of "Strengthening International Law: Parliamentary Roles and mechanisms and the contribution of Regional Cooperation". The Assembly adopted an Outcome Document on the theme of the General Debate at its concluding Session. Speaker, Lok Sabha also participated in the Breakaway session of Speakers' Dialogue on Development and Economy held on the sidelines of 141st IPU Assembly. Shri Sasmit Patra, MP, Rajya Sabha also participated in the General Debate and presented India's views on the topic from youth perspective. India Group of IPU also Proposed a Resolution

on "Addressing Climate Change" during the 141<sup>st</sup> IPU Assembly for inclusion in the Agenda of the Assembly as an Emergency Item. Dr. Shashi Tharoor, MP introduced the Indian proposal to the Assembly and made a brief statement on the theme of the proposed Resolution. India's proposal received the highest number of affirmative votes and was included in the agenda of the Assembly as an Emergency Item. After a detailed discussion, the Assembly adopted a Resolution on the Emergency Item. Shri Sasmit Patra, MP, a member of the Indian Parliamentary Delegation acted as the Rapporteur on the Resolution Drafting Committee.

The Members of Indian delegation attended various other meetings during the Assembly, such as Asia-Pacific Geo Political Group (APG) of IPU, Asian Parliamentary Assembly, IPU; Advisory group on Health, Governing Council, Four Standing Committees of IPU, Forum of Young Parliamentarians and Forum of Women Parliamentarians etc.

A meeting of BRICS Parliamentary Forum was also held on the sidelines of the Assembly. The theme of the BRICS Parliamentary Forum was the "Role of Parliamentarians in Promoting intra BRICS Health Cooperation. Ms. Kanimozhi Karunanidhi,MP, Lok Sabha attended the meeting of the BRICS Parliamentary Forum.

Smt. Snehlata Shrivastava, Secretary-General, Lok Sabha and Shri Desh Deepak Verma, Secretary-General, Rajya Sabha attended the Meetings of Association of Secretaries General of Parliament (ASGP) held during the above event.

On the sidelines of the 141<sup>st</sup> Assembly, Speaker, Lok Sabha held bilateral meetings with the following dignitaries: (i) HE Ms. Gabriela Cuevas Barron, President, IPU(ii) HE Ms. Ana Brnabic, Prime Minister of Serbia.(iii) HE Ms. Maja Gojkovic, Speaker of the National Assembly of Serbia.(iv) HE Dr. Ali Ardeshir Larijani, Speaker of Parliament of Iran.(v) HE Ms. Laura Rojas Hernandez, President of Chamber of Deputies of Mexico, (vi) HE Ms. S.S Choudhury, Speaker of Parliament of Bangladesh. During the Assembly elections were held for the vacant posts in various IPU bodies. Shri Sasmit Patra, MP, Rajya Sabha and Smt. Raksha Nikhli Khadse, MP, Lok Sabha were unanimously elected for the membership of (i) IPU Committee to Promote the Respect for International Humanitarian Law and (ii) the Board of the forum of Young Parliamentarians of IPU, respectively.

The Sixth G 20 Parliamentary Speakers' Summit(P 20) jointly organized by the House of Councillors of the National Diet of Japan and the Inter Parliamentary Union, Geneva was held in Tokyo, Japan from 3 to 5 November, 2019.

Shri Om Birla, Speaker, Lok Sabha accompanied by Smt. Snehlata Shrivastava, Secretary General, Lok Sabha participated in the aforesaid Summit. Sh. PC Koul, Joint Secretary, Lok Sabha Secretariat was the Secretary to the Delegation.

The Summit included three sessions on the following themes:

- Session I- "Promotion of Free, Open and Fair Trade and Investment"
- Session II- "Utilization of Innovative Technology towards a Human-Centered Future Society"
- Session III.- "Efforts towards Resolution of Global Challenges and Achievement of the SDGs (Financing for Development, Need for Transparent and Effective Government etc)".

Speaker, Lok Sabha attended the above three Sessions and delivered the key note address during Session-II. Speaker also intervened and made a Statement during Session-III. At the end of the Summit a 'Joint Statement" was also adopted. During the Visit, Speaker, Lok Sabha also addressed a select gathering of the Indian Diaspora in Tokyo. The Event was organized by Embassy of India in Tokyo, Japan.

# 8. 2<sup>ND</sup> EXECUTIVE COUNCIL MEETING AND 12<sup>TH</sup> PLENARY SESSION OF ASIAN PARLIAMENTARY ASSEMBLY HELD IN ANTALYA, TURKEY FROM 13 TO 18 DECEMBER, 2019.

An Indian Parliamentary Delegation comprising of Smt. Meenakashi Lekhi MP, Lok Sabha (Leader of Delegation); Dr. Hina Vijaykumar Gavit, MP, Lok Sabha; and Dr. Narendra Jadhav, MP, Rajya Sabha participated in the 2nd Executive Council Meeting and 12th Plenary Session of Asian Parliamentary Assembly (APA) which was held in Antalya, Turkey from 13 to 18 December, 2019. Shri Abhijit Kumar, Additional Secretary, Lok Sabha Secretariat was Secretary to Delegation.

The theme of the Plenary Session was "The Role of Multilateral Cooperation among Asian Parliaments". At the end of the Plenary, an Outcome Document titled 'Antalya Declaration' was adopted.

### 9. <u>INAUGURAL SESSION OF PEOPLE'S MAJILIS (PARLIAMENT OF MALDIVES)</u>

Shri Rajiv Pratap Rudy, MP, Lok Sabha attended the Inaugural Session of People's Majilis (Parliament of Maldives) held on 3 February, 2020 in Male, Maldives. Shri Rajiv Pratap Rudy, MP, during his visit to Male, Maldives also held meetings with the authorities concerned in Maldivian Majilis. The meetings were primarily aimed at devising the mechanisms that can take forward the matters which were discussed between the two Presiding Officers and the Secretariats of the two Parliaments during their respective earlier interactions.

# 10. <u>MEETING OF THE 45<sup>TH</sup> SESSION OF THE STEERING COMMITTEE OF PARLIAMENTARY CONFERENCE ON WTO</u>

Shri Rajiv Pratap Rudy, MP, Lok Sabha participated in the meeting of 45th Session of the Steering Committee of Parliamentary Conference on WTO held in Brussels (Belgium) on 20 February, 2020.

During the meeting following agenda items were discussed:

- (i) Reform of WTO
- (ii) Brief on the upcoming 2020 Annual Session of the Parliamentary Conference on WTO.

At the end of the Meeting a Statement was also adopted.

# (B) <u>CONTRIBUTION TO THE CENTRAL FUNDS OF THE INTER-PARLIAMENTARY</u> <u>UNION (IPU):</u>

Indian Parliamentary Group's Annual Contribution of CHF 1,12,900/- (Rs. 82,41,700/-) to the Central Fund of the Inter-Parliamentary Union for the year 2020 was paid out of the grant sanctioned by Parliament. Also, an amount of CHF 550/- (Rs. 40,500/-) has been contributed to ASGP.

### COMMONWEALTH PARLIAMENTARY ASSOCIATION (CPA) RELATED EVENTS

India is a member of the Commonwealth Parliamentary Association (CPA). The Lok Sabha Secretariat functions as the Secretariat for the India Branch of the CPA and the Secretariat for the CPA India Region. The India Branch of the CPA entered the Seventieth Year in 2019-20. India Region Branch which was a part of Asia Region became a separate Region of the CPA in September, 2004. The following events took place during the period under review:

### 1. MEETING OF PRESIDING OFFICERS OF LEGISLATIVE BODIES IN INDIA

A Meeting of Presiding Officers of Legislative Bodies in India was held on 28 August, 2019 in New Delhi. The Presiding Officers deliberated on various burning topics concerning the Legislatures in India. At the meeting, Speaker, Lok Sabha and Chairperson of AIPOC proposed to constitute the following three Committees of Presiding Officers:

- (a) Committee of Presiding Officers to evaluate the use of Communication and Information Technology (C & IT) in the functioning of Legislatures and suggest way forward under the Chairpersonship of Shri Hitendra Nath Goswami, Speaker, Assam Legislative Assembly;

The Committee have sought detailed information in the form of a List of Points from State Legislatures with a view to finalize their Report.

The 79<sup>th</sup> Conference of Presiding Officers of Legislative Bodies in India was held in Dehradun, Uttarakhand on 18 and 19 December, 2019. Shri Om Birla, Speaker, Lok Sabha and the Chairperson of the Conference inaugurated the Conference at a solemn function held in Dehradun, Uttarakhand. The Speaker, Uttarakhand Vidhan Sabha, Shri Prem Chand Aggarwal delivered the Welcome Address at the Inaugural Function. The Chief Minister of Uttarakhand, Shri Trivendra Singh Rawat attended the Inaugural Function and also addressed the Inaugural Session.
